## SECTION 4: COMMITMENTS OF THE OWNER

3. I certify that all information provided about the animal to Mission Mayday is true.
4. I understand that it is at the discretion of Mission Mayday to provide me with information as to the condition of my pet.
5. I understand that I may not adopt this animal when it becomes available, nor may a member of my circle. Once I have signed this contract, the animal cannot be returned to me.
6. I agree not to take legal action against Mission Mayday to regain custody of this animal.
7. I agree not to make any unsubstantiated criticism or misinformation about the organization on social networks or other public platforms or Mission Mayday may take legal action against me.

## SECTION 5: COMMITMENTS OF MISSION MAYDAY ORGANIZATION

1. Mission Mayday undertakes to respect the legislation in force concerning animal welfare in its territory of activity.
2. Mission Mayday undertakes to provide all necessary care to the animal in order to optimize its chances of survival and to reduce its suffering as much as possible.
3. Mission Mayday undertakes to provide basic care to the animal in order to find it an adoptive family.
4. Mission Mayday undertakes to keep the animal's owner's information confidential and to never divulge to the general public any information that would allow the owner to be traced.
5. Mission Mayday reserves the right to transfer the animal to a partner organization if its current resources do not allow for optimal care of the animal in a reasonable time frame.

6. Mission Mayday reserves the right to euthanize the animal if prognosis is bleak or quality of life is poor.
